DESCRIPTION

APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE TRANSPORT AND LABOUR RESOURCES TO MOVE OFFICE FURNITURE, OFFICE EQUIPMENT, CROCKERY, CUTLERY AND BOXES OF HARD COPY DOCUMENTATIONS TO A STORAGE FACILITY MAXIMUM DISTANCE 35 KM.

1. PURPOSE

The South African Forestry Company SOC Limited (SAFCOL) is seeking proposals from reputable, competent and qualifying service providers to provide transport and labour services to move office furniture, office equipment, crockery, cutlery and boxes of hard copy documentations to a storage facility maximum distance 35 km.

2. BACKGROUND

2.1. Introduction

The SAFCOL Pretoria Office is currently located in Lynwood Glen, Pretoria, Gauteng. The current lease agreement expires at the end of December, therefore all office furniture, equipment, cutlery and boxes of hard copy documentation must be moved and stored at a designated storage facility identified by SAFCOL.

2.2. Objectives of the required goods/services

The objectives of acquiring this service is to move the office furniture, office equipment, cutlery and boxes of hard copy documents to a secure and safe facility on temporal bases while a medium to long term office space is arranged.

2.3. Expected benefits for the company

The movement of furniture will enable the company's assets to be transported safely and stored while the company finalizes a medium term office space lease agreement.

3. SCOPE OF WORK

3.1 The scope of appointment includes the following:

- a) Dismantle office desks and boardroom tables. Load, transport, offload and stack at designated storage areas.
- b) Loading and transportation and offloading and stacking of office chairs, visitors chairs, boxes with hardcopy documents, Filing cabinets, Credenzas safes, Fridges and kitchen cutlery at designated storage areas.
- c) The designated storage facility must fall within a 35 km radius from the existing offices.

- d) Equipment (i.e lowbed/flatbed trucks) to move all items over a distance of 50 metres from the building to the moving truck as there are no parking directly in front of the building.

4. PROJECT TIMELINES

5. COMPETENCIES, EXPERIENCE AND SKILLS REQUIREMENTS OF THE SERVICE PROVIDER.

The bidder must be able to provide through its own means all equipment, materials, supplies, vehicles and related services necessary to provide full removal services.

1.
