iThemba LABS produces radiopharmaceuticals such as ¹⁸F-FDG, ¹²³I-solution, ¹²³I-capsules, ¹²³I-mIBG and ⁶⁷Ga-citrate on routine daily basis for the nuclear medicine community of South Africa. As part of the regulatory requirements, a Responsible Pharmacist that is a permanent staff member of iThemba LABS is authorised to release the final radiopharmaceutical product.
